A1: VAT, is an indirect tax that applies to buying and selling, that is, a transaction-based tax.If you don't have the VAT number, You can apply for registration on the website of your local tax authority

Q2: Who is the legal representative ?

A2: A legal representative of the business has specific powers and is legally authorized by your business to manage and act on its behalf (for instance: accepting terms and conditions, opening a payment account, etc.). The legal representative may or may not be an owner of the business.
